

Contest Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

- 1. Eligibility:** This Campaign is open only to those who are 13 years of age or older as of the date of entry. The Campaign is only open to legal residents of the United States and Canada, and is void where prohibited by law. Employees of Snowledge, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the “Employees”), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Campaign. The Campaign is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules.
